1001/06 **A REPORT FROM CORNWALL COUNCILLOR ROY TAYLOR**

Councillor Taylor informed us that he is now a member of a Fire Panel whose goal is to improve the Fire Service in Cornwall. The Waste Panel have decided not to cancel the contract with SITA and he is a member of the new homeless strategy team.

1001/07 **A REPORT FROM CORNWALL COUNCILLOR DAVID HUGHES**

Councillor Hughes had attended the planning meeting last evening where the Wain Homes development at Par Lane was given permission. Neither the Environment Agency nor South West Water are yet satisfied that the flood and drainage issues have been dealt with sufficiently. There is a condition in place that these issues must be dealt with to the satisfaction of the agencies as well as Councillor Hughes and Taylor.

Councillor Hughes urged the Council to attend any planning meeting where we have objected to a proposal as our voice would have more influence.

Councillor Hughes told that Council that we will be consulted by Highways regarding street gritting in bad weather.

Network Rail has installed a short wave radio system and as a result 30 meter high masts will be installed at Par Docks and Stoneybridge.

1001/08 **OVERVIEW OF TOWN PLAN**

The Council read the correspondence from Councillor Srafton and all agreed that the Town Plan is a worthwhile project that will in due course benefit the town. The Council will encourage Councillor Srafton to continue with his commitment to the project.

1001/09 **STREET CLEANING IN ST BLAZEY.**

The Clerk has contacted environmental services at Cornwall Council regarding our concerns regarding waste disposal and street cleaning and been informed that the contract with Serco runs until 2016 and that it would not be easy to dismantle part of the contract before then. The Clerk will arrange for a speaker to attend February's meeting.

1001/10 **INVESTMENT IN HIGH INTEREST ACCOUNT**

The Clerk has received the paperwork from the high interest account, the Council decided to defer re-investment to next months meeting.

1001/11 **PARKING PROBLEMS.**

The Clerk asked Cornwall Council for their schedule for patrolling St Blazey and the costs and although this was not forthcoming they promised more patrols which are happening. The Clerk informed the Council that this isn't a task easily taken on as apart from paying the cost of training and employing staff, the Town Council do not have the resources for court costs if fines are not paid.

1001/12 **CAROL CONCERT – OVERVIEW & DONATIONS**

The Carol Concert was a great success; everybody agreed that De-ja-Vue should be asked to attend next year. The Boys Choir from Biscovey Junior School were great. The Council looked at the costs for the event and decided that the Male Voice Choir should be replaced by a local school choir this year.

De Ja Vue performed for free and but have asked for a Charitable donation, Councillor Allen proposed £50 Councillor Putt seconded all the Council agreed and so it was RESOLVED.

The Biscovey Junior School performed for free but have been informed that they cannot attend as many events as they would like due to the cost of travel. Councillor Gill proposed writing to them offering to pay travel costs for an event with a cap of £100, Councillor Goddard seconded the proposal, all the Council agreed and so it was RESOLVED.

1001/13 **ST BLAISE FEAST DAY**

Camilla Baker from the Eden Project and Liz Davies from Biscovey School have organised St Blaise Feast Week from 3rd to 7th February 2010. They have worked with St Blazey Church and other local organisations to arrange a Lantern Parade on Wednesday 3rd February which will begin at Polgrean Place and finish at St Blazey Church where a service and blessing of Throats will take place; this will be followed by Refreshments and fireworks at the Football Club.

The Council have been asked to attend and asked for a donation of £100 to pay for the band. Councillor Hooper proposed that we proceed, Councillor Goddard seconded and all the Council agreed as so it was RESOLVED.

It is hoped that this event will be held annually in the future.

1001/14 **PROJECT LIST**

New Community Centre – The Clerk met with Colin Whitehead and Jackie Arthur from Happy Days on Monday 30th November 2009. Happy Days are currently unhappy with the security arrangements as the last person to leave has to walk away from the building in the dark. St Blazey Councillors agreed to install a timed security light. Another problem is that smokers do not use the smoking area, the Clerk believes this is because the area is not signed, Councillors agreed to pay for a Sign. There is a problem with visitors to the Centre not knowing the difference between Happy Days and the Burrows Centre reception. The Clerk has spoken to Councillor Anderson about this who has asked the Burrows Centre Board if appropriate signage can be arranged, they agreed.

Bus Shelter - The new bus shelter for Station Road which was installed on Wednesday 2nd December has been placed on private land, the Clerk will make arrangements to move it to Lamellyn Road.

Footpath outside Kemutec - The Clerk has not received a reply from the new owners of Kemutec with regards to installing a pavement from the bus shelter to the Doctors Surgery, the Clerk will write a reminder. The Luxulyan Valley Partnership are inviting requests for local community grants with profits from the turbine, the Clerk will request funds to help to pay for a footpath if we receive permission.

Community Energy - The Clerk has arranged a meeting with James Kittow for Monday 15th February to discuss if he is able to help with a Community Energy Project.

1001/15 **TOWN CLERKS REPORT**

The Clerk has been asked by a member of the Public to write to Theresa Frost thanking her for the drainage work that was organised by her in Station Road in December; the Council agreed this should be done.

The Clerk told the Council about a flood protection open day that is to be held at Alexander Hall on Thursday 11th February.

The Clerk informed the Council that the CALC AGM will be on 20th February and that Councillor Scrafton and she will attend.

The Clerk forwarded the letter to Highways from Eden Neighbours Forum asking us to clear the road surface and vegetation from Eden to Carvear Lane, they have replied asking for our support, the Council do not believe the road is wide enough for white lines and believe the vegetation is the land owner's responsibility.

Graham Rowe from Cornwall Council Building Control attended the planning meeting on January 18th 2010 to discuss areas in St Blazey suitable for affordable housing. We have two figures for the amount of people awaiting affordable housing in St Blazey 276 and 348. This figure will be decreased if the affordable housing is built in Par Lane by 75. The planning Committee suggested land on the other side of the A390 currently outside the development envelope.

St Blaise Town Council would like to see mixed housing and therefore would expect to see approximately 400 homes to be built which then becomes a new community which would need to include medical and educational facilities. This would need to be a phased development. Graham Rowe will start by looking at the need for educational services, speak to Highways and the Primary Care Trust and report back to us.
