Compliance status

The web-site is partially compliant as it meets most requirements of the Web Content Accessibility Guidelines listed below.

Various menu elements and heading elements don't conform to html guidelines, which causes a non-conformance to WCAG 2.2. To resolve this a re-structure of the html elements is to be implemented, following best practice to allow all screen readers to parse the content properly.

The repeatable header and footer elements aren't skippable when navigating using a keyboard. This is a non-conformance to WCAG 2.2 To resolve this appropriate hooks will be implemented after all header content, which will allow the user to tab past the header on 'non home' pages.

Although this issue isn't present in the webpages, a large portion of the PDF documents don't specify the language in which the content is presented. There is a high chance this will prevent screen readers be able to parse through the information and thereby violates WCAG 2.2. Moving forward PDFs will be generated specifying language and content structure to enable them to be more accessible.

Any new PDFs or Word documents we publish will meet accessibility standards.
